

## Items required for the approval of safety glazing materials

Pursuant to the Compulsory Specification for safety glass and other safety glazing materials as published by Government Notice No. R. 363 (Government Gazette No. 37631) of 16 May 2014.

The following items are required for an application for the approval of a type of safety glazing material:

## Α **Proof of payment**

Proof of payment of a non-refundable application fee for the approval of the type of safety glazing material as published in the Government Gazette in terms of section 14(3)(b) of the National Regulator for Compulsory Specifications Act, 2008 (Act No. 5 of 2008). The amount of the nonrefundable application fee may be requested from the NRCS CMM Approvals Section:

Where applicable, the availability of at least one specimen for each of the following commodities when the type of safety glazing material is supplied in glazing applications other than stock sheets:

- Curved glazing panes;
- b) Pre-fabricated walls consisting primarily of glazing material;
- Glazing fixed in walls and horizontally sliding doors of lifts; c)
- d) Pre-fabricated doors and sidelights consisting primarily of glazing material;
- Pre-fabricated doors and sidelights fitted with glazing; e)
- f) Glazing fixed in pre-fabricated window frames;
- Pre-fabricated glazed bath enclosures and shower cubicles; g)
- h) Glazing in pre-fabricated balustrades;
- Glazing in pre-fabricated internal partitions; i)
- Glazing used in the construction of furniture; i)
- Glazing used in fish tanks (aquariums);
- Glazing in pre-fabricated underwater observation panels;
- Weather shelters for public transport passengers fitted with glazing; m)
- Pre-fabricated display cabinets and notice boards fitted with glazing.
